Designed by acclaimed local firm Alterstudio Architecture and built by Becky Fuller Homes, the residence is tucked into a private enclave on Westlake Drive, just minutes from Lake Austin and downtown.

With a layout that lives like a single-family home, this property offers exceptional comfort and privacy. The home is in the coveted Eanes ISD, and zoned to Bridge Point Elementary. It features three inviting outdoor living spaces, including a spacious second-level deck. Native landscaping and thoughtfully placed hardscapes define outdoor spaces while offering a lush sense of privacy.

The sleek interior is filled with light, thanks to floor-to-ceiling windows and expansive glass doors that frame the greenery beyond. Natural wood floors contrast beautifully with gallery-finish white walls, creating a perfect backdrop for an art collection. Designer finishes throughout include Ann Sacks tile, custom lighting, marble and quartz counters, and custom cabinetry.

Upstairs, the primary suite features a skylit



bath, large walk-in closet, and a generously sized glazed privacy window that fills the space with natural light. A separate second-level deck offers additional outdoor space and expands the home’s entertaining potential.

A downstairs covered porch was thoughtfully enclosed with sliding glass doors to create an office. If desired, the space could easily be reimagined as a lounge, playroom, or returned to its original use – offering flexibility to suit your lifestyle.

The entire home is a wired smart home, outfitted with Lutron systems for lighting and shades, WiFi extenders, ethernet wiring, and ATT fiber – ensuring seamless, high-speed connectivity throughout, both indoors and out.
